



2025 MEMBER POLICIES

Guests of The Oxford Hills have an ongoing obligation to behave in a respectful manner in line with our organization's code of conduct. In line with this, members are expected to respect and adhere to The Oxford Hills' policies and regulations. We expect our members to uphold the standards of personal conduct and reflect a positive image for other members and guests of the club.

Alcohol Policies

The Oxford Hills strictly adheres to all provisions of the provincial liquor control and licensing regulations. The organization assumes no liability for any wrongdoing, or problem caused by the breach of these rules. No alcoholic beverages other than those provided by The Oxford Hills are permitted anywhere on the premises. We reserve the right to examine the contents of golf bags and other items for personal alcohol. The Oxford Hills strives to create an environment in which guests experience a safe and pleasant stay every time they visit our facilities. Members and guests are encouraged to use and enjoy our facilities, but are required to comply with all of TOH policies, as well as all regulations of the Alcohol and Gaming Commission with respect to the service and consumption of alcoholic beverages.

Harassment

The Oxford Hills has a Zero Tolerance Policy

against harassment, abuse, bullying and discrimination. Any type of disruptive behavior or form of abuse constitutes grounds for The Oxford Hills to modify how it interacts with the individual(s) involved. Those who are found to be in violation of our zero-tolerance policy may face a variety of disciplinary actions, including written or verbal reprimand, suspension or forfeiture of membership. Any such actions will be taken by management in consultation with ownership and decisions will be final in any instance.

Membership

The Oxford Hills' golf memberships provide members with the right to use the facility available to that membership category upon payment of applicable fees. It does not provide a member with any ownership or equitable interest in the club or the facility or other assets owned by the organization. The Oxford Hills shall use all reasonable efforts to have the club's golf course available to playing members during the golfing season. The closure of all or portion of the premises for repair, maintenance, improvement, corporate events, or any other instance, shall be permitted at the sole discretion of the club. The Oxford Hills shall have the right, in its absolute discretion, to accept or reject any application for membership and is not required to provide reasons for its decision to accept or reject an application for membership.

Membership Refund Policy

Memberships are non-refundable and non-transferable, except for medical or special circumstances. A member suffering injury that prevents him/her from playing golf is eligible for a prorated credit to be redeemed for future membership dues. A medical note from a doctor is mandatory for eligibility. The prorated/refund amount may vary based on specific duration of time or special circumstances, which determined at The Oxford Hills' discretion. The golf season is typically 200 days, ending on November 1st of each calendar year, weather depending.

Member Booking Policies

Utilizing the tee sheet properly is imperative to running a smooth fair operation for our members and customers. Maximizing the tee sheet effectively will allow The Oxford Hills to establish proper scheduling, improve pace of play, and optimize availability. Please review the booking policies below.

14-Day Advance Booking

Members can book tee times up to 14 days in advance. The member tee sheet will open at 9 p.m. the night before the two-week window. For example: you can book your round for Tuesday April 16, 2025 on Monday April 1, 2025 at 9 p.m.

Public 7-Day Advance Booking

Public players will be allowed to book their round of golf 7 days in advance. This allows members to have priority of tee times.

Online Booking

Members names must be entered when booking your round online. When booking, you can select playing partners through Tee-On. Adding a playing partner will properly assign that spot to that member, a conformation will be sent, and the round will be added to their profile.

Cancellations/No Shows

Members are obliged to call or email the pro shop if they cannot play their scheduled tee time 24 hours in advance. Failure to do so will result in a \$25 no show charge. Last season, we had too many no shows and unfilled groups, which took up tee times that could have been booked by other members and golfers. No show fees will be billed to members' profiles and will need to be settled before the end of the day (i.e. credit card on file will be charged).

Group Bookings

There are multiple groups that would like a standing tee time on certain days. We will be taking requests to see if we can work out a schedule for the upcoming golf season. Group bookings will be available for groups of members and guests 8 or more. Group bookings can be requested Monday – Thursday before 8 a.m. or after 10 a.m., and Saturday and Sunday before 8 a.m. Please fill out the standing tee time request form (available at the pro shop once the golf season starts). Tee times will not be guaranteed if a fair solution cannot be met. No show penalties still apply.

Check In

Members must check in with the pro shop before they play. This will ensure that our tee sheet remains accurate. If members do not check in, they could be marked as no show, resulting in no show charges.
